Chapter 2 Concrete Measures for Crime Victims and their Progress

1. Efforts to recover the victims' damages and to provide them with economic support

(1) Supporting Victims to Claim the Compensation for Damages, etc.

OMain efforts

 Consideration on the support offered by the Japan Legal Support Center and implementation of the measure (Ministry of Justice)

Ministry of Justice and the Japan Legal Support Center are considering the Center to support the fee to allow the attorney to have psychological counselor present at meetings with crime victims in the process of preparation and litigation to claim compensation for damages.

(2) Improvement of the systems concerning the benefits and other payments

OMain efforts

• Improvement of the current Benefit System for Crime Victims Practices (National Police Agency)

The Benefit System for Crime Victims has been enhanced over the years, such as a major revision of the Act on July 2008 in creased bereaved family benefits for the bereaved families who were in the same household economy with the victim and disability benefits for people with severe residual difficulties (disability levels 1 through 3). In addition, in October 2009, provisions of special exceptions were reviewed to enable full payment for the spousal violence case with particular necessity of the remedy. The amount of the crime victim benefits paid in the fiscal year of 2011 reached around 2,065,000,000 yen, the highest ever.

The members of the consultation group conducted hearings about the operational status of the Benefit System for Crime Victims after the enhancement, social security systems, the payments of crime victim benefits (hearing from bereaved family) and the victims' and bereaved

families' economic situation after the victimization (hearing from victims and bereaved family).

Ministry of Health, Labour and Welfare has notified local governments that it is possible to exclude crime victim benefits from income recognition under the special circumstances typical to crime victims.

(3) Ensuring a Stable Residence

 Priority in tenant selection for publicly managed housings and other measures (Ministry of Land, Infrastructure and Transport)

(4) Stabilization of Employment

OMain Efforts

 Raising the awareness and promotion for the understandings on the leave system for recovering victims (Ministry of Health, Labour and Welfare)

The surveys conducted in 2011 found that more than 90% of companies and employees were not even aware of the fact that there is an opinion to seek a leave system for the recovery when a worker was victimized by a crime. Therefore, in order to raise awareness and promote understandings for the introduction of such system at the work places, in 2011, the Ministry of Health, Labour and Welfare

created leaflets and posters and sent them to 224 organizations including economic organizations and labor organizations, and held seminars. Efforts for awareness raising and promotion will be continued in the fiscal year of 2012 also.



2. Efforts for the victims to recover from or to prevent mental and/or physical damage

(1) Provision of healthcare services and welfare services

OMain Efforts

- Providing information about medical institutions at where PTSD treatment is available (Ministry of Health, Labour and Welfare)
- Enhancement of counseling opportunities offered by police for victims of sexual crimes (National Police Agency): See Chapter 1

OMain Efforts

 Appropriate operation of measures such as video links (Ministry of Justice)

This measure consists of appropriate operation of the system to properly reflect victims' voice to court proceedings such as the statement of opinions of crime victims and the system aimed at reducing the burden and anxiety of victims during witness testimony, such as video-link and other shielding measures. Between January and December of 2011, the total number of witnesses who were allowed to have accompanying person during the witness examination was 136, the total number of witnesses who used shielding measures was 1,317, and the total number of witnesses whose examination was conducted through video link was 242.

3. Efforts to broaden the opportunity for victims to participate in criminal procedures

(1) Development of the System to Broaden the Opportunities to Participate in Criminal Procedures

OMain Efforts

• Consideration to cover the travel and other expenses of victim participants (Ministry of Justice)

Ministry of Justice is considering the introduction of the system to reduce the burden of travel and/or other expenses borne by crime victims for them to appear to the court under the victim participation system.

 Reconsideration on the level of financial resource requirements for victim participants to be eligible for courtappointed attorneys at law (Ministry of Justice)

Ministry of Justice is reconsidering, in addition to the travel and/or other expenses of victim participants mentioned above, on the mitigation of financial resource requirements for victim participants to be eligible for the court-appointed attorneys at law.


