1. Enhancement of public awareness, development of social awareness, and international collaboration

O Promotion of public relations and awareness-raising for the prevention of victimization

· Held the "Public Symposium for Preventing Youth Crime and Victimization" during the "National Month for the Prevention of Juvenile Delinquency and Juvenile Damage" (July 2019). [CAO]

O Information dissemination at home and abroad

• Organized the 4th Specialist Group Meeting on Child Sexual Exploitation (January 2020) to introduce the activities of private groups and efforts of prefectural police departments for the prevention of child sexual exploitation; about 220 representatives from relevant ministries and agencies, foreign institutions, private groups, and others attended the meeting. 2. Support for children and families to ensure the growth of children without victimization

O Awareness-raising activities for safe and secure internet use

- · Organized awareness-raising seminars for safe and secure internet use by young people. [MIC, MEXT, and METI]
- · Produced a leaflet featuring specific criminal incidents and modus operandi, and distributed the leaflet to the boards of education, etc. [MEXT and NPA]



3. Promotion of measures to prevent the occurrence and spread of victimization that focuses on tools

O Assistance in measures against tools taken by private organizations

- Provided information regarding child victimization cases and trends of victimization at the Conference for Development of Internet Use Environment for Young People. which was organized to promote voluntary efforts to prevent child victimization, such as via information-sharing among SNS operators, research, and public relations & awareness-raising activities. O Response to inappropriate messages on SNS

• Promoted the efforts of prefectural police departments to call public attention to inappropriate messages on SNS that could lead to child sexual exploitation, while also taking child victims into custody. [NPA]

5. Strengthening of crackdowns and rehabilitation of offenders

6. Strengthening of the foundation for realizing a society where children will never become victims

O Strengthening of the structure and specialization of Child Guidance Center

· Strengthened the structure and specialization of Child Guidance Centers and municipalities based on the "Comprehensive Reinforcement Plan for Child Abuse Prevention Measures System" by increasing the number of child welfare officers (by approximately 2,020 persons) over four years starting FY2019 and by setting up child and family general support bases in all municipalities.
